- The pump strainer shall consist of a _____ (red brass/cast iron) body, cover with O-ring seal, threaded locking handles and a strainer basket of _____ (ABS/perforated electro-polished stainless steel basket) material.
- The strainer body shall have ______NPT threaded connections and mount directly to the pump body by means of a bolt, flange and gasket seal, or 6" ANSI Rated 125 lb. bolt flanged with fusion-bonded epoxy coating on all wetted cast iron surfaces unless specified for in-line mounting ahead of the pump. The strainer body shall have a removable drain plug for winterizing.
- The strainer basket shall be securely positioned below the suction inlet of the trap, with access for inspection and cleaning through a removable trap body lid. The trap body lid shall be secured by means of threaded locking handles. The strainer basket shall have perforations which, in total area, are equal to 6 times the open area of the suction pipe into the trap body inlet.
- The pump strainer shall be Sta-Rite® Model No.


